Read these competition rules carefully. These competition rules ("rules") explain your rights and duties under this competition. If you take part in this competition or accept any prize, these rules will apply to you and you agree that the person running the competition ("the promoter/s" or "FNB") can assume that you have read and agreed to be legally bound by these competition rules.

- 1. The FNB Win Back your 1<sup>st</sup> Deposit Competition ("Competition") is organised and conducted by First National Bank of Namibia Ltd ("FNB").
- The Competition will run from 1<sup>st</sup> August '21 at 00:00:01 and will strictly close on 31<sup>st</sup> October '21 at 23:59:59. Transactions made after the closing date will not be considered by FNB for this competition.

## WHO CAN QUALIFY?

- 3. The Competition is open to all new to bank FNB Gold Lifestyle Account holders that are in good standing and entrants must be in possession of a valid ID or Passport.
- 4. Participants who are directors, members, partners, employees, agents of or consultants of FNB, its subsidiaries, holding companies, divisions and/or associated companies or of the advertising or promotion agencies or any other person who directly or indirectly controls or is controlled by FNB, will not qualify to participate in the Competition and will also not be eligible for any prizes.
- 5. By entering this Competition, all participants agree to be bound by these terms and conditions, and FNB's decision regarding any issue with the Competition will be final and binding and no correspondence will be entered into.

# HOW TO QUALIFY?

- To qualify, customers need to open a Gold Lifestyle Account via the FNB App or Website, activate your account by depositing into their FNB Gold Lifestyle account (to a minimum amount of N\$5 000 and a maximum amount of up to N\$20 000)
- 2. Participants must transact via the FNB App with a minimum of two transaction. E.g.: Purchasing electricity or purchasing airtime.
- 3. Winners will be determined based on minimum number of successful transactions achieved through FNB App. Winners will be selected randomly by a randomiser application during the Competition period.
- 4. FNB does not accept any responsibility for any transaction that is not delivered, received or is delayed or damaged due to technical reasons, including telecommunication failure on the part of the participant's service provider, or otherwise.
- 5. Participants acknowledge and agree that they may incur costs or other charges ordinarily associated with using a FNB Gold Debit Card.

## PRIZES

- The prizes consist of 2 x winners monthly for a period of 3 months. After every month FNB will announce 2 winners that will win their 1<sup>st</sup> deposit into their FNB Gold Lifestyle account back (to a minimum amount of N\$5 000 and a maximum amount of up to N\$20 000)
- 7. There will be 6 draws in total, 2 x monthly winners. Each draw will consist of a randomiser to pick any two customers who meets the following criteria:
  - a. New to bank FNB Gold Lifestyle Account holder in good standing.
  - b. The customer has transacted at least 2 times on the FNB app by purchasing airtime or buying electricity per month; and
  - c. The customer has made a successful deposit into their FNB Gold Lifestyle account

Totalling 2 winners each month, and 6 winners overall for the Campaign Period.

- 8. Only one win per customer.
- 9. Winners will be notified by call or SMS on the following dates:
  - 2nd week of the following Month
- 10. The prizes do not cover any other costs of the winner whatsoever.
- 11. The prize is limited to cash which will be paid into the winner's respective accounts used for transacting and swiping.
- 12. FNB reserves the right to substitute the prizes for an alternative prize of equal or greater value should the prizes promoted not be available due to unforeseen circumstances.

#### PUBLICITY AND DATA PRIVACY

- 16. The prize winner must accept that his/her name and/or likeness may be announced in FNB's media publications or on the Internet for publicity or advertising purposes without additional compensation, except where prohibited by law.

#### GENERAL

- 17. FNB reserves the right to shorten, extend, suspend the time period of the Competition or terminate the Competition whenever it should so choose for technical, commercial, or operational reasons, or for reasons beyond its control or generally for any reason whatsoever within their sole discretion. The Competition, its prizes, and terms and conditions may be amended by FNB, at any time during the Competition, and will be applied and interpreted within its sole discretion. In such an event, all participants waive any rights that they may have/purport to have in terms of this Competition and acknowledge that they will have no recourse against FNB whatsoever.

- 21. ## IMPORTANT:
