Please read these competition rules carefully. These competition rules ("rules") explain your rights and duties under this competition. If you choice to take part in this competition or accept any prize, these rules will apply to you and you thereby agree that the person running the competition ("the promoter/s" or "FNB") can assume that you have read, understood and agreed to be legally bound by these competition rules.

- 1. The FNB Visa Swipe to Win Competition ("Competition") is organised and conducted by First National Bank of Namibia Ltd ("FNB").
- 2. The Competition will run from 15 November 2021 at 00h00 and will close on 15 February 2022 at 00h00. Transactions made after the closing date will not be considered by FNB.

WHO CAN QUALIFY?

- 3. The Competition is open to all FNB NAMIBIA Commercial Customers whose businesses are registered as Sole Proprietors that are in good standing and entrants must be in possession of a valid ID or Passport to qualify.
- 4. Participants who are directors, members, partners, employees, agents of or consultants of FNB, its subsidiaries, holding companies, divisions and/or associated companies or of the advertising or promotion agencies or any other person who directly or indirectly controls or is controlled by FNB, will not qualify to participate in the Competition and will also not be eligible for any prizes.
- 5. By entering this Competition, all participants agree to be bound by these terms and conditions, and FNB's decision regarding any issue in relation to the Competition will be final, binding and no correspondence will be entered into.

HOW TO QUALIFY?

- 6. To qualify, customers need to swipe with their FNB Business Debit and / or FNB Business Credit Card
- 7. Participants may swipe their FNB Business Debit and / or FNB Business Credit Card as many times as they choose.
- 8. Participants qualify for an entry into the draw when they have swiped three (3) times or more during the Competition period.
- 9. FNB does not accept any responsibility for any transaction that is not delivered, received or is delayed or damaged due to technical reasons, including telecommunication failure on the part of the participant's service provider, or otherwise.
- 10. Participants acknowledge and agree that they may incur costs or other charges ordinarily associated with using a FNB Business Debit and / or FNB Business Credit Card.

PRIZES

- 11. There are two sets of winner categories:
 - Business Debit Card Winners swipe 3 times per month will be drawn.
 - Business Credit Card Winners swipe 3 times per month will be drawn.
- 11.1. Each winner will receive a cash prize of N\$5000.
- 11.2. The cash prize will be paid will be paid into the customers' <u>Business Debit or Business Credit Card account.</u>
- 11.3. Only one win per customer, whether Debit or Credit card.
- 11.4. Customers will be notified about their winnings through an official FNB email address.
- 11.5. The prizes do not cover any other costs of the winner whatsoever.
- 11.6. The prize is limited to cash which will be paid into the winners' respective accounts used for swiping.

- 11.9. PUBLICITY AND DATA PRIVACY

GENERAL

FNB reserves the right to shorten, extend, suspend the duration of the Competition or terminate the Competition whenever it chooses for technical, commercial, or operational reasons, or for reasons beyond its control or generally for any reason whatsoever within their sole discretion. The Competition, its prizes, and terms and conditions may be amended by FNB, at any time during the Competition, and will be applied and interpreted within its sole discretion. In such an event, all participants waive any rights that they may have/purport to have in terms of this Competition and acknowledge that they will have no recourse against FNB whatsoever.

To the fullest extent permitted by law, by participating, the participant indemnifies, releases and agrees to hold harmless FNB, their associated, holding and subsidiary companies, and its directors, officers, agents, representatives, shareholders, employees, successors and assigns from any and all claims or liability arising from participating in the Competition, any Competition-related activity and/or acceptance, receipt, possession or use/misuse of any prize.
- 18. To the extent permitted by law, FNB will not be liable in any way whatsoever, for any claims arising from loss, injury, damage or costs, suffered by a participant in relation to this Competition or the prizes offered, including

but not limited to claims relating to defects in the prizes or any losses caused by such defects or losses arising from incorrect or inaccurate information supplied by participants.

- 19. FNB will not be held liable for any loss suffered as a result of incomplete or incorrect information provided.
- 20. Namibian law shall govern these competition terms and conditions and the courts of Namibia shall have exclusive jurisdiction.

IMPORTANT:
