

FNB APP COMPETITION

GENERAL TERMS AND CONDITIONS

Date these rules were first published: 26 October 2018

Date these rules were last changed: 30 October 2018

Read these competition rules carefully. These competition rules ("rules") explain your rights and duties under this competition. If you take part in this competition or accept any prize, these rules will apply to you and you agree that the person running the competition ("the promoter/s" or "FNB") can assume that you have read and agreed to be legally bound by these competition rules.

- 1. The FNB App Competition ("Competition") is organised and conducted by First National Bank of Namibia Ltd ("FNB").
- 2. The Competition will run from 26 October 2018 at 06h00 and will strictly close on 26 January 2019 at 23h59. Entries received after the closing date will not be considered by FNB.

WHO CAN ENTER?

- 3. The Competition is open to all FNB Namibia customers who have an account with FNB that is in good standing and entrants must be in possession of a valid ID or Passport.
- 4. Participants may not enter or receive a prize if they are directors, members, partners, employees, agents of or consultants of FNB, its subsidiaries, holding companies, divisions and/or associated companies or of the advertising or promotion agencies or any other person who directly or indirectly controls or is controlled by FNB.
- 5. By entering this Competition, all participants agree to be bound by these terms and conditions, and FNB's decision regarding any issue with the Competition will be final and binding and no correspondence will be entered into.

HOW TO ENTER

6. To enter, participants simply need to download the FNB App from their respective mobile phone App Store and use the App to transact on their FNB account.

- 7. A transaction on the FNB APP for purposes of this competition includes, without limitation:
 - Buying airtime or electricity
 - Paying for your DSTV
 - Sending money via eWallet
 - Transferring money between your accounts
 - Paying someone
 - Making a card-less cash withdrawal at an FNB ATM
- 8. Entries are unlimited.
- 9. Entries must be by the participant submitting them and not by a third party on the participant's behalf.
- 10. Entry is NOT possible by SMS. All entries, including incomplete entries, may be billed by your service provider. The Promoters shall not be responsible for telecommunication failure on the part of the participant's service provider.
- 11. FNB does not accept any responsibility for any entry that is not delivered, received or is delayed or damaged due to technical reasons, including telecommunication failure on the part of the participant's service provider, or otherwise.
- 12. Participants acknowledge and agree that by entering this Competition, they may incur data costs and/or other costs by their mobile services provider, ordinarily associated with the download of the FNB App.

PRIZES

- 13. The prizes consist of 50 Huawei p20 Lite Smartphone's only. The winners' prize will consist of the 50 Huawei p20 Lite Smartphones only and will not include any sim cards, airtime, or other mobile phone related products.
- 14. Winners will be drawn using a randomized electronic tool and the draw will be verified in the presence of FNB Namibia's auditors. FNB's decision is final.
- 15. Winners will be announced by call or sms on the following dates:
 - 16 winners will be announced by 30 November 2018 and 16 phones will be given away.
 - 17 winners will be announced by 31 December 2018 and 17 phones will be given away.
 - The final 17 winners will be announced by 31 January 2019 and 17 phones will be given away.
- 16. Winners need to claim their prize within 30 (thirty) days of announcements, by presenting a valid Namibian ID or passport. It is the responsibility of the winner to collect his/her prize at their own cost.
- 17. The prizes do not cover any other costs of the winner whatsoever.
- 18. The prizes may not be exchanged for cash.
- 19. FNB reserves the right to substitute the prizes for an alternative prize of equal or greater value should the prizes promoted not be available due to unforeseen circumstances.
- 20. FNB will not be liable for any loss suffered as a result of incomplete or incorrect information provided.

FNB reserves the right to withhold prizes in the event that it reasonably believes, in its sole discretion, that the winner is not eligible to win, has contravened any of these terms and conditions, has acted in a manner that is not in the spirit of the Competition, their conduct can be reasonably interpreted as scamming or circumventing the rules of the Competition, acted fraudulently with regards to the Competition, if it would be unlawful to award the prize or if the winner fails to accept the prize after 14 (fourteen) attempts for any reason whatsoever. In this instance the winner will be disqualified and forfeit the prize. FNB's decision shall be final and no correspondence will be entered into.

PUBLICITY AND DATA PRIVACY

- 21. By entering the Competition, a participant acknowledges that personal information about him/her will be shared with FNB and their agents to the extent necessary to conduct the Competition.
- 22. The prize winner must accept that his/her name and/or likeness may be announced in FNB's media publications or on the Internet for publicity or advertising purposes without additional compensation, except where prohibited by law.

GENERAL

- 23. FNB reserves the right to shorten, extend, suspend the time period of the Competition or terminate the Competition whenever it should so choose for technical, commercial, or operational reasons, or for reasons beyond its control or generally for any reason whatsoever within their sole discretion. The Competition, its prizes, and terms and conditions may be amended by FNB, at any time during the Competition, and will be applied and interpreted within its sole discretion. In such an event, all participants waive any rights that they may have/purport to have in terms of this Competition, and acknowledge that they will have no recourse against FNB whatsoever.
- 24. All publicity and other materials will be the sole property of FNB.

NB: Please note that the following terms require you to take on risk, limit the liability of FNB and indemnify FNB. Please read them carefully and contact FNB if you have any questions!

- 25. FNB is not liable for any technical failures affecting participation in the campaign and they assume no liability in this regard.
- 26. To the fullest extent permitted by law, by participating, the participant indemnifies, releases and agrees to hold harmless FNB, their associated, holding and subsidiary companies, and its directors, officers, agents, representatives, shareholders, employees, successors and assigns from any and all claims or liability arising from participating in the Competition, any Competition-related activity and/or acceptance, receipt, possession or use/misuse of any prize.
- 27. To the extent permitted by law, FNB will not be liable in any way whatsoever, for any claims arising from loss, injury, damage or costs, suffered by a participant in relation to this Competition or the prizes offered, including but not limited to claims relating to defects in the prizes or any losses caused by such defects or losses arising from incorrect or inaccurate information supplied by participants.

- 28. FNB will not be liable for any loss suffered as a result of incomplete or incorrect information provided.
- 29. Namibian law shall govern these competition terms and conditions and the courts of Namibia shall have exclusive jurisdiction.

IMPORTANT:

- You agree to indemnify the promoter(s) fully for any loss or damage the promoter(s) may suffer because you breached the competition rules. This means you agree to reimburse the promoter(s) for the following: any loss or damage they suffer, any expenses and costs they paid or are responsible for. Legal costs mean costs on an attorney and own client scale.
- You also agree to indemnify the promoter(s) for any loss or damage you suffered because you took part in this
 competition or used the prize. If you enter yourself, or use or accept the prize, you understand that you do so of
 your own free will. This means that you cannot hold the promoter(s) legally responsible for any loss or damage or
