Who Should Invest?

The FNB Namibia Money Market Fund is suitable for investors seeking a low risk investment that maximises income. It offers a high income yield, capital stability and good liquidity.

Investment Objective

The fund's objective is to achieve an investment return in excess of general money market instruments and funds, while ensuring a high degree of liquidity, capital preservation and below average risk. The fund invests primarily with the four major banking groups in Namibia, the five major banking groups in South Africa, Nampost Namibia and the Namibian, - and South African governments. Securities to be included in the portfolio consist of money market instruments, participatory interests in unit trust schemes, bank call and fixed deposits, fixed income securities, government bills and bonds, quality commercial paper and repurchase agreements.

Unit Trust prices are calculated on a net asset value basis, which is the total capital value invested including any income accrual and less any permissible deductions from the portfolio divided by the number of units in issue. Income accruals are made daily and paid out monthly. Purchase and repurchase requests may be received by the manager by 10h00 each business day. Permissible deductions may include management fees, brokerage, NAMFISA levies, auditor's fees, bank charges, trustee fees and RSC levies. A schedule of fees and charges is available on request from Ashburton Unit Trust Management Company. Commission and incentives may be paid and if so, would be included in the overall costs. Fund Commentary

After lifting the US policy rate by a further 25bps in July to 5.50%, the Fed has paused with its tightening cycle during September but has prepared the market for further potential hikes.

Namibian (4.7%) and South African (4.8%) headline inflation prints have come in higher for August, with further upward pressure expected during 4Q23, driven by higher oil prices from geopolitical tension in the middle east.


The Namibian policy rate (7.75%) still lags the South Africa's policy rate (8.25%) by 50bps. The market now prices in a further hike from here and interest rates to remain higher for longer.
