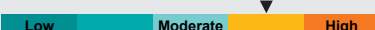

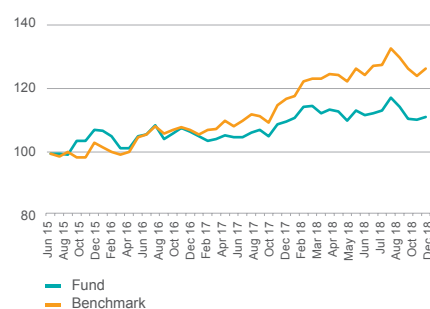
### Investment objective

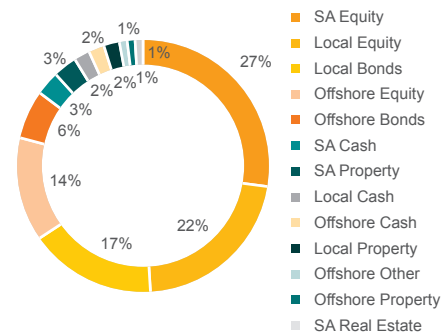
### Investment strategy
