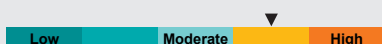

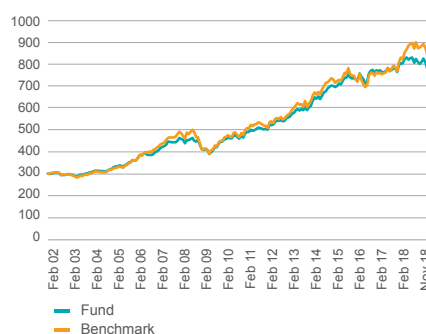
Investment objective

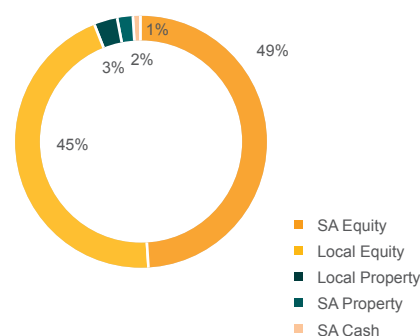
Investment strategy
